RESIDENCE ADDRESS: YOUR VEHICLE REGISTRATION SHOULD HAVE YOUR RESIDENCE ADDRESS AND NOT YOUR MAILING ADDRESS. DMV SENDS THE BILLING INFORMATION TO THE TOWN OF RESIDENCE. PLEASE BE SURE YOUR REGISTRATION READS SCOTLAND. WITH A TAX TOWN CODE OF 123.

We will work with the Town of Scotland & DMV for a yearly verification of this.

When will you be receiving your tax bills?

Real Estate and Personal Property tax bills have 2 installments which will be mailed out the last week of June 2019 with a due date of July 1, 2019 and January 1, 2020. Motor Vehicle bills have 1 installment due July 1, 2019. All July installments must be received or postmarked by August 1, 2019 to avoid interest. The second installment will be due on January 1, 2020 and must be received or postmarked by February 3, 2020 to avoid interest.

IN HOUSE PAYMENTS

You can come in to our office at 979 Main Street, Willimantic, CT to pay in person. Acceptable forms of payment are cash, checks, Mastercard, Visa, and Discover. There is a small vendor fee for the use of a credit or debit card. **All checks should be payable to Town of Scotland.** *Should you receive a parking ticket while paying your taxes, please contact our office.*
