Return Service Requested

You are responsible for ensuring this declaration is received by the Assessor's Office. If you cannot hand deliver it, obtain a Certificate of Mailing from the post office (less expensive than Certified Mail) or send it by Certified Mail. To avoid the 25% penalty, you must show the Assessor the proof of mailing AND provide a copy of the declaration sent.

2018 Declaration of Personal Property for All Registered and Unregistered Campers/Trailers/RVs Located at Highland Campground, Scotland, CT

Filing Requirement – You are required to file this declaration annually with the Assessor if the personal property is located in Scotland on October 1, 2018 and was located in Scotland starting on or before July 1, 2018 (Conn. Gen. Stat. §12-41 + §12-43).

Penalty for Late Filing, Non-Filing and Omission of Data – There is a **25%** penalty added to your assessment if:

- The Declaration is not received by November 1, 2018, or has a postmark later than November 1, 2018;
- The Declaration is received on-time but property is omitted; or
- No Declaration is filed (Conn. Gen Stat. §12-41(e), §12-42).

The penalty CANNOT be removed by the Board of Assessment Appeals (Conn Gen Stat. §12-114, §12-119a).

Extension – A request for a filing extension for good cause (§12-42) is possible if it is received on or before Wed., 10/31/2018.

DUE DATE IF MAILED: MUST HAVE A POSTMARK ON OR BEFORE Thursday, November 1, 2018

If you no longer own the personal property assessed in your name or if you moved it out of Scotland, return this declaration and provide information on the property's disposition (see below). Otherwise, the Assessor assumes you still own the property and failed to file.
